The weather was a little wet one day, but the shooting was fun for everyone. I went a few days early to take advantage of the fine reloading room to work on loads for a pistol I recently rebarreled. OKC can be proud of that building and the help it is to out of the area shooters.

For myself that match marks the end of outdoor shooting for the year as all of our ranges up north are buttoned up for the winter. That doesn't mean we can't shoot, it just means we have to do it indoors. We have a winter air pistol silhouette league that has matches every-other Saturday that allows us to keep shooting. SANCTION FEE RULES REMINDER

Per SECTION IX: Match Procedures of the IHMSA Rule Book:

4. Delinquency in remitting sanction fees may affect the designation of 'good standing' of a match. The following policy applies to delinquent remittance of sanction fees:

A) Matches more than 30 days delinquent (60 days after the date of the match) shall not be eligible to send delegates to the annual business meeting.

B) After 90 days delinquency (120 days after the date of the match), the matter will be brought up for review of sanction revocation by the Executive Committee

5. Any organization hosting sanctioned matches that fails to adhere to IHMSA rules may have their sanction withdrawn by the Executive Committee. In the event of sanction being withdrawn, the affected organization shall, upon written request to the Secretary/Treasurer, be able to have the decision reviewed by the Board of Directors.

CASTING, A WHOLE NEW GAME

Region 8 (North Dakota, South Dakota, Nebraska, Wyoming, and Colorado) is now seeing winter starting to show up and that tends to slow down our shooting opportunities. This is not uncommon for those regions that experience snow as the norm this time of year. Some hearty soles are still out burning powder, and my hat is off to them. Even though not all of us have started to see snow on our ranges, other competing interests tend to deflect our silhouette friends into other areas this time of year. Even so, we have had one of the best years that we have seen in quite some time. Participation in many if not all of our State and Regional matches in Region 8 showed excellent numbers ranging from near 100-200 guns being shot. Yes, not the days of old, but I would also add that we live in a different time that has many different and exciting things to do. Hope your regions are seeing improvement as well.

I have been asked by numerous individuals about how to get started in making and using cast bullets for competition. This series of articles may provide some insight into that development. I will be the first to admit that there are many of you out there that are currently competing with cast bullets, if not all, that are more knowledgeable than I in the art of casting bullets. This article is focused on how a beginner, such as me, can get into the casting game and actually be competitive against those that shoot jacketed bullets. I love not only shooting IHMSA competitions, but also love the challenge and reward of doing it with cast bullets. Some of you may think this is nuts, but to the others, let's dance.

First misconception, shooting cast bullets is cheaper than jacketed. While this may be true once you are fully set up for cast bullets, it may not seem like it at first due to the equipment that it takes. So, let's discuss some of the minimums that you might consider and how to cut those costs. Don't forget to ask around at your range for these materials, someone may have them and be willing to part with them at a reasonable price. If not, there is always eBay.

It should also be noted here that when ever you are melting lead it should be done in a well-ventilated area. I wait until the weather is nice outside and then do it there on the porch. Should also wash your hands thoroughly after handling lead. Long sleeved shirt, long pants, shoes, gloves and safety glasses are also highly recommended. The little splatters of lead do burn a little.

Items you will need to get to the final ingot stage:

- Lead: May seem obvious, but you have to have lead to make cast bullets. Lead can be found in various ways outside of directly purchasing it, which by the way, is the easiest. Areas to look for lead:
 1. Old shower pans, watch out for any that have tar on them, makes a mess in your pot
 2. Old lead service water pipes to old homes,
 3. Wheel weights. Old ones. Newer tend to be of a different alloy and not any good for casting, at least that I can figure out
 4. Best source is range lead that you can find at your local range back stops. Some ranges do not allow members to "Mine" the lead, but if yours does, look to the pistol ranges as a positive source. Not too hard to get 30 or 40 pounds of the stuff in an hour. This is my preferred source. My wife actually seems to love scavenging for old lead bullets. I'm usually ready to go before she is.
- Heat source such as an old Colman stove
- Melting pot
- Scraping spoon
- Beeswax (flux)
- Pliers to pore the pot into the ingots (couple of channel locks work well)
- Ingot mold. I like the cast iron Lyman one best from those that I have tried
- Tin
- Antimony (such as 30% from Rotometals)
- Safety glasses
- Leather Gloves
- Hardness tester (Lee)
- Punch set and hammer (optional)

Once your lead source is at home, you will need to process it into bars which makes it easier to store and to work with later as you will see. To process, I found that my old Colman single burner camping stove works really well. Found a small 10-pound cast iron pot at a garage sale real cheap and with this equipment I process the raw lead. Reason I like these is because it is far easier and safer to pour the lead into the ingots with this equipment than using the furnace I cast from. One thing I found that helps start the pile of lead in the old pot to melt is to hit the lead with a MEP gas plumbers torch until a small puddle of lead is in the bottom. One caution on this step is to make sure your lead is dry. Since we scavenge our lead in the summer I will let it dry until fall before we process. Water and melted lead are not

very good partners. Wear safety glasses anytime you are dealing with molten lead, you won't be sorry. Once melted in the pot, you will notice that there is a lot of dirt, gas checks, and many other unknown items on the surface. You will need to clean this off before you pour the lead into the ingot molds. Take an old spoon that no one will miss and scrape the junk off the surface and dispose of it. I drop it into an old green beer can for ease.

Next step will be to flux the molten lead to get the rest of the impurities out. I have tried many different flux products, all work and work well, but I have found that good old fashion bees wax works great and it can be found cheaply and is easy to work with. To prepare the bees wax melt it (in a pan I found at a garage sale) and pour it into a shallow mold. I made with ¼ inch screen door molding strips and parchment paper. Same thing can be done with an old cookie sheet. Really easy. Experience note here, don't use the kitchen pans unless you want to buy the owner a new set.... Does not take to much bees wax to flux, around a pea to marble size chunk will do just fine. Stuff does smoke, so if that bothers you, just light the smoke with a match and it will burn. While the bees wax is melting, stir the lead working it in. You will start to see an ash like material on the surface, if not you did not add enough, and that is what you will be removing before putting it into the ingot mold. I place the ingot mold on top of a wet rag to cool the lead quicker while I'm processing all the raw lead. Speeds up the process without having to buy multiple molds. Pour the lead into the ingot molds utilizing pliers or other safe methods. Now you have a pile of ingots to start to work with. The pile of ingots is a shiny, beautiful sight, might even bring a tear.

I know some that will use this range lead as is and go right into casting bullets after they get to the ingot stage, and it works for them. I like to develop the lead into specific hardness levels for the bullets I shoot. I find it adds to the consistency and reduces or eliminates leading. Checking hardness is not to difficult and I check each ingot. Numerous testers are on the market, some cheap like Lee, while others are available at a higher cost. I have found the Lee tester to work good enough for my needs but I'm sure that the others may work even better, but I do not know. Takes about 10 seconds to scrape a clear spot on the ingot and then 30 seconds to press the lead with the Lee tool in your loading press. Then you measure the diameter of the indent with Lees device and you can determine the hardness of the lead in BHN units. I have found that range lead generally has a BHN of around 15. For the loads I use, I need to up that hardness to a BHN 17 and a BHN 22. I would hesitate to go much higher than BHN 22, for the lead mix is starting to get a little brittle at that level. I have an old punch set that I punch the BHN into the ingot for future reference. You can scratch it in as well.

To achieve the higher BHN's requires Tin (Sn) and Antimony (At). An old thumb rule that someone told me is that for every 1% Tin added to your mix, you will see an increase in BHN of 0.3. Also, for every 1% of Antimony added to your mix you will increase BHN by 0.9. These seem to work well but are

generalities. I do not add tin to my mixes with range lead since there is generally enough Tin already in the lead. I think of it as more of a wetting agent to help the lead fill the bullet molds better. The easiest place I have found to obtain antimony is to order it on line from Rotometals in their super hard lead (30% Antimony). Makes it easy. Linotype is another source but not as easy to find unless you have really good friends that no longer cast. I will blend my range lead into the BHN 22 ingots first and then use these ingots to develop my BHN 17 ones. Don't really know why I do it, but it works for me. One thing about the harder leads, they take 2-3 weeks to reach full hardness once you pour them. A friend explained this to me once, but don't recall anything he said only that the bourbon was good that we were drinking while he explained it. I did a little trial though and found he was right. So, wait to test your blended ingots for a few weeks and you will have numbers that are more consistent. Now your lead is ready to start casting bullets and we will discuss that in the next article. Have fun with this, it's a whole new world.

They will not be posted if they are not sent to me. I just do not have the time to go through all of the match reports looking for BBRP qualifying scores.

Jim Kesser (OH) shot some excellent scores at the World Championships this year. They were his best scores of the year but not his only entries by far. Jim shot a P-78, U-79, R-76 and a S-57. These convert to a 3-gun 107 and a 4-gun 145. In another match Jim also added a S-29 and a US-31 for a Standing aggregate of 60.

Eric King (CA) shot a S-27, P-40, U-39 and a R-36. These add up to a 3-gun 106 and a 4-gun 142. At 77, this may make Eric the oldest person to make the 140 club.

Joe Cullison (OR) Shot a great November match. Joe shot a S-35, P-37, R-38, a U-40 and a US-38. 5 guns in one day is a whole lot of concentration. These add up to a 3-gun 113, a 4-Gun 151 and a Standing aggregate of 73. These also get Joe into the 30+ standing and 35+ Unlimited standing categories.

State totals for 2017 are: NV-5, OH-5, OR-5, MN-4, CA-2, IN-1, WY-1

But, 2 record tying standing scores were shot this last year! Both have been verified by the match directors. The scores are listed below.

In April, Wayne Boston of PA shot a standing score of 37x40! This ties the standing record set by Gary Rex of OH in 2007.

During the world championships, Doug Edney of PA tied the 80 round standing score of 68x80! The record was set by Jeff Hunt of OH in 2004

Paul Habig of NV shot a 3 and 4 gun aggregate of 106 and 143 (S:26,P:37,R:40,U:40) last February.

Joe Kennedy of NV shot a standing aggregate of 62 (S:26,US:36) in NV.

John Richards of MN shot a 60 round 3 and 4 gun aggregate of 165 (110) and 221 (147) scores during the Minnesota state championship. The Scores were S:48, P:59,R:58,U:56.

BARREL LENGTH VS. VELOCITY TESTING

We conducted velocity testing to help our customers answer the seemingly hardest question when it comes to ordering a new custom barrel: What length? With the velocity testing data we've collected, making that decision is easier than ever. Now our customers can know how much, if any, difference there is at a specific length.

We built six of our most demanded Encore barrels at 27" (our maximum barrel length), then we tested and recorded the velocity. The barrels are: 6.5mm Creedmoor, 280 Remington Ackley Improved, 444 Marlin, 450 Bushmaster, 460 Smith & Wesson Magnum, and the 45-70 Government. We then cut an inch off each barrel and retested again, repeating the process 14 times, ending at 13". The ammunition we selected for the tests were a combination of popular factory loaded average weight bullets, to the heavier-than-standard hand loads. We wanted to cover the most sought-after bullet weights for the caliber so our testing was as relevant as possible to anyone.

All of the barrel cleaning and shortening was done here at Match Grade Machine. The hand loads were put together by Steve's Custom Guns, a local enthusiast. Steve also performs all of the load data for customers who don't want to take the time to tune loads to their barrels or if they are experiencing difficulties with their own setup. We have to commend Steve for his thorough data collection and willingness to spend the time to painstakingly shoot six barrels, then shorten and repeat.

For practical reasons people are going with shorter barrels because 50-100 fps isn't that much of a difference for cartridges and their distance capabilities. Due to many reasons, shorter barrels are easier to tune and handle, therefore have greater accuracy potential.

Take a look at the first velocity testing results we have compiled and see for yourself how length affects performance on firearms.

6.5mm Creedmoor

The 6.5mm Creedmoor has been one of, if not the most, desired barrels we build for the Encore. The combination of light recoil, and excellent trajectory, mixed with the versatility to be chambered in short action rifles, semi-autos, and of course the T/C Encore, has led many folks to make this their cartridge of choice. Being a 6.5mm, the bullet selection varies from ultra-light varminting bullets, all the way up to the heavies with ballistic coefficients in the .6's. We tested three different weights for this cartridge in our velocity testing, and we were quite impressed with the results.

No matter what shooting style is chosen, it's best to know the velocity range at a length before purchasing. As you can see, length on the 6.5mm Creedmoor is a factor that affects performance, so make sure to research your application and make your decision wisely.

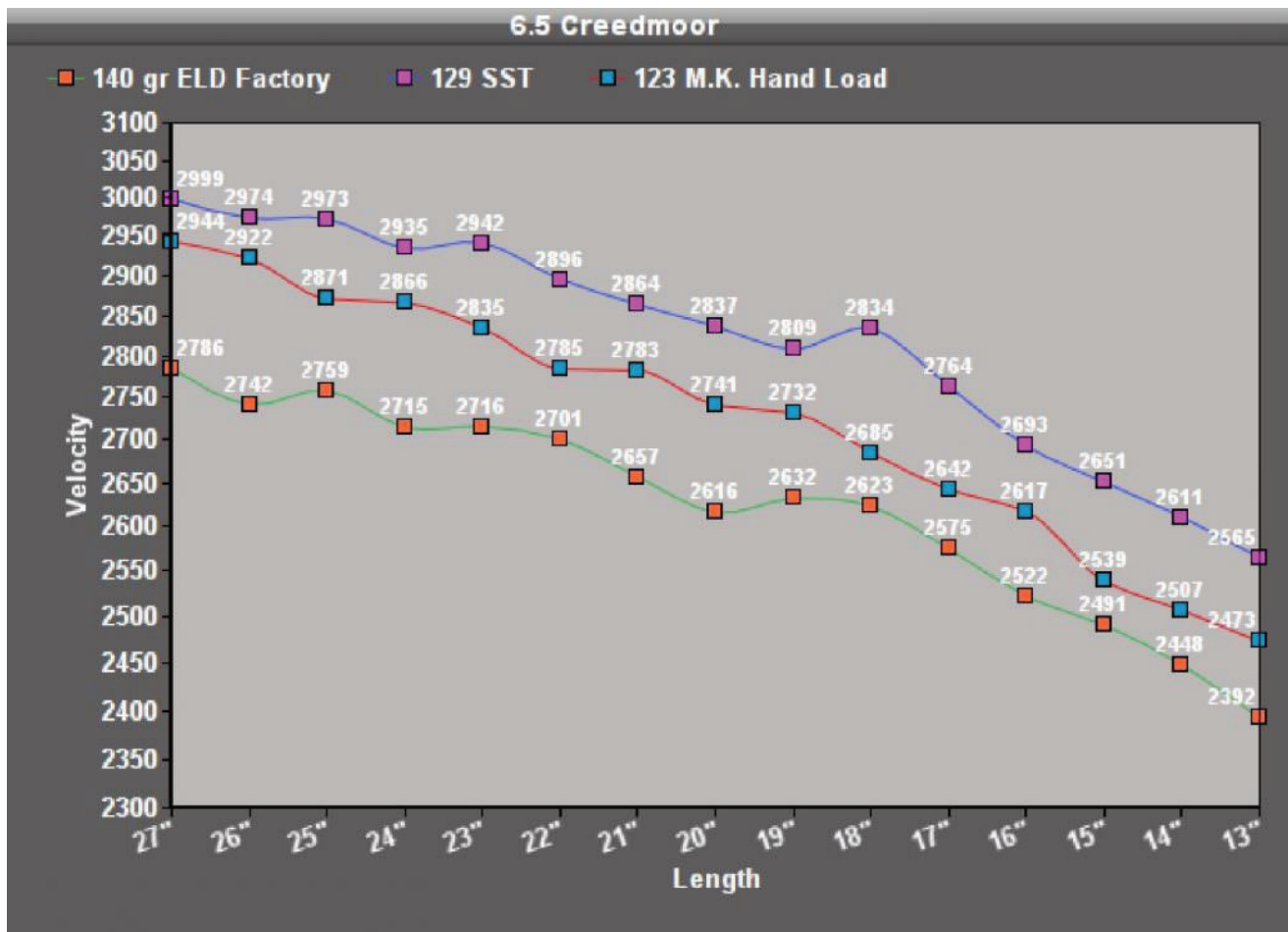
