## Flying with Guns to California

This past weekend I hopped on a plane with my silhouette guns to shoot a match at LASC. Things went well and I would like to share the experience in case anyone is concerned about taking guns to California for the World Championships this July 10-17th.

I took a full complement of silhouette guns including 6 serial numbers, 3 contenders, 2 FA's and an Anschutz along with another 5 barrels. The airlines limit bags to 50 lbs. so even with all of this hardware, a lockable hard case and a couple of pad locks, I came in right at 50 lbs. My other case contained ammo for all and a couple of changes of clothes. Of course, I had to pay \$25 for the first bag and because I can't travel light, another \$35 for the second.

Flying with guns is not difficult if you follow the rules. The guns must be unloaded and transported in a lockable case, preferably a hard sided one. A soft sided lockable case may be allowed but I would not recommend it. Your ammo may be shipped ahead of time or carried in a separate locked case. For the World Championships, you may ship your ammo to the Angeles Shooting range, just make sure to contact

them first and mark IHMSA World Championships on the shipping label.

Plan on arriving at the airport at least an hour before the normal recommended time. This will allow you time to check your guns and still make your flight. (It usually only takes about 15 minutes extra but it is better to be safe – trust me.) When you go to the baggage counter, quietly inform the baggage / ticketing clerk that you have firearms. They will have you sign a TSA form that declares the firearms are unloaded. On this form you can write down your cell phone number in case the TSA needs to contact you while you are in the airport. It is a carbon copy form and the agent will have you place one copy in the gun case. You do not need to fully open the case, just crack it a bit and slip the paper inside.

BE PREPARED to wait for 10 to 30 minutes with your key or combination handy. Stay near the baggage counter, the TSA WILL want to see inside your case. If the agent tells you to go to the gate, don't do it! If you are not handy or have already gone through security, they will call you back from the gate to open your case. (Then you get to go through security again. Yippee!) You and your case could miss your flight. You may request to be present

when they open your case. I run about 50% success with that request. If you have key locks they will request your key, if you have a combination lock, they will need the combination. If you have a combination lock you may be able to give that over the phone if they call your cell phone number you wrote on the carbon copy declaration form mentioned above.

As far as California goes, you may bring any firearm you legally own in the state where you live. You may not sell any of your guns in California and you may not buy any while you are there but you may bring your own and then take them home when you leave. Once you arrive in California, put the locked case in the trunk or if you are in an SUV, as far back as possible. In a locked case and out of reach of the driver is what they want to see on the odd chance that you happen to get stopped. Your ammo should be in a separate locked case and also out of reach of the driver.

Easy enough and usually, surprisingly, a smooth process. Not a big deal, I'll fly with guns to California again.

# Wildcat Corner

I'd be willing to bet that I'm not the only one who has more than 3-dies for a given cartridge or handgun/rifle and get frustrated because more than 3-dies will not fit into a typical plastic commercial die box. Forester does make a box where you can get 4-dies into it. Along the same lines, despite the fact that some shell holders work with more than one cartridge, I like having a dedicated shell holder in each die box.

A recent rifle project saw me having 5-dies that I wanted to keep in a common box. The dies included:

- ∅ Full length resizing/decapping die
- ∅ Factory case mouth expander
- ∅ Factory bullet seating die
- ∅ Lyman M-die for case mouth expanding
- ∅ Lee factory crimp die
- ∅ Shell holder

This is for a Marlin 336 chambered in .38-55 Winch.

A suitable common box was finally found but it isn't made by one of the traditional loading die companies. I found this one in the fishing section of a Cabella's catalog. The enclosed photo shows how it is just about the correct size. It measures about 10 3/4" x 5 1/2" x 1 3/4". It is made by Plano and is their model 3610.



If there is a negative, the really long Competition dies made by Redding or RCBS are too long....but....a carefully cut round hole on the face of the box in the desired compartment, would allow them to be stored. That's an inexpensive solution. Now here are two more expensive options.

Another route is to make or have one made for you out of wood. The photo here shows a box made for my C. Sharps Model 74 chambered in .40-70 Sharps Straight.



Another wooden box was made by a friend for me. This one holds all of my assorted .30-06 dies, etc. To do it over I would have made it flat like the 74 Sharps die box. That long flat design stores better on the reloading room shelves.



And lastly, how about all of those cast bullet sizing dies and nose punches? The 3-box photos shows a J&J Products ammo box converted to store these items along with cast bullet lube.



The goals here are to better organized and save time during reloading by not looking for and retrieving multiple die storage boxes. Designing the custom boxes is a fun activity that adds to the FUN of shooting!

## Rules Addendum: Practical Hunter

**Class Description:** All 3 classes are to be shot from any SAFE freestyle position including prone, kneeling, sitting, or standing.

The Practical Hunter Long Course will be shot on the 200 meter Big Bore range with the standard full size targets at their normal ranges.

The Practical Hunter Short Course will be shot on the 100 meter Field Pistol range with the standard targets at their normal ranges, using standard field pistol cartridges only.

The Practical Hunter .22LR Course will be shot on the 100 yard SB range with the standard Small Bore targets at their normal ranges.

**Class Rules:**

- Any hunting style handgun with

a maximum overall length of 21 inches.

- Optics are allowed up to a maximum of 6x power.
- Gun must be as manufactured with only cosmetic modifications.
- Ported barrels are allowed as long as they are shot from a safe position.
- A rest such as a bipod or a sand-bag supporting the barrel in a prone position may be used by a new unclassified shooter and by shooters in classes A and AA.

- A 0-15
- AA 16-25
- AAA 26-38
- INT 39-40

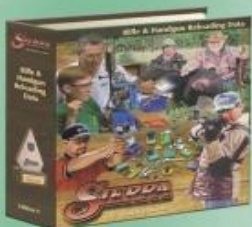

**Request for Nominations**

**Office of Secretary/Treasurer of IHMSA, Inc.**

Article VII, Section I of the IHMSA bylaws states the following: "Officers: The officers of the corporation shall consist of a President, Vice President, and Secretary/ Treasurer. Officers shall be elected every year prior to the annual business meeting held in conjunction with the International Championships. Officers shall assume their official duties following the close of the annual meeting and shall serve for a term of three years or until the election and qualification of their successors. To ensure stability, the term of office of the officers shall be staggered."

For 2013, the office of Secretary/Treasurer of IHMSA, Inc. was scheduled to be filled by election of the Membership held prior to the 2013 annual business meeting. However, no nominations were received. Mr. Alkire, the current Secretary/Treasurer has continued to serve until replaced, With his current work duties, Mr. Alkire is no longer able to devote the time needed to carry out this office and someone else is needed to fill that position. Therefore, this is a call for nominations for the office of Secretary/Treasurer:

The IHMSA bylaws state that all nominations must bear the signature and endorsement of the nominee and signatures of two other financial members of the corporation, Also each nominee may provide a statement of claims of not more than 500-words that cites why he/she should be elected to the office for which he/she is being nominated.

Article VII, Section 3 of the IHMSA bylaws describes the "Nominations Officer" whose job it is to receive the nominations for the Executive Officer positions and conduct the election. This officer is appointed annually by the Board. Dell Taylor is again serving this year as the Nominations Officer. For that reason Mr. Taylor's address is listed on the nomination form below and is the person to whom the nominations should be sent.

Candidates for the office of Secretary/Treasurer should use the nomination form provided below or a facsimile thereof to declare their candidacy. The nominations Officer must receive no later than the 1<sup>st</sup> of March 2015. Candidates will be declared in the April edition of the IHMSA news if more than one nomination is received.

The statement of claims mentioned in above must also be received by the 1st of March 2015 in order to be published in the April edition of the IHMSA News. Therefore, candidates should submit the statement of claims with their nomination.

**Duties**

The duties of the Secretary/Treasurer are specified in Article VIII, Section 3 of the IHMSA, Inc. bylaws. For easy reference, that section is reproduced below.

"Section 3. Secretary/Treasurer: The Secretary/Treasurer shall ensure the recording of all decisions of all meetings of the corporation, Executive Committee, and Board of Directors. He shall perform such other duties as may be assigned to that office from time to time.

"The Secretary/Treasurer shall on a quarterly basis, furnish the members of the Board an up-to-date financial statement, with the cycle of reporting beginning with an annual financial report presented to the Board and the annual business meeting of the corporation held in conjunction with the International Championships. This report is to show the financial position of the corporation as at the end of the quarter immediately preceding the annual business meeting.

"The Secretary/Treasurer shall present a full, half-year and annual financial report to the membership via the pages of the IHMSA News. As a general rule, such reports will not have been subjected to external audit."

"The Secretary/Treasurer shall be responsible for ensuring the maintenance of all books of account and records so as to conform to the requirements of these bylaws. If so determined by a majority vote of the board, the day to day record keeping of the financial affairs of the corporation shall be contracted out to and an individual/ firm qualified and properly licensed to undertake such activity, Notwithstanding such a decision the Secretary/Treasurer remains responsible for the provision of the periodic reports referred to above."

## THE NEW SILHOUETTER,

### It's Not all Credible

Shortly after I submitted my last tirade about the .380 another article crossed my desk that included a review of a gun in that caliber that had a poor trigger pull and failures with one-third of the ammunition that was tested. Nevertheless, apologizing for the incompatible ammunition, the bottom line was a positive recommendation for this pistol. This was about the time that the Brian Williams reporting scandal hit the news. Is there a connection?

Perhaps I was under the delusion as a youth that published news, regardless of medium, was reporting what had occurred, without any bias or agenda. Since I am a believer that the more things change the more they stay the same, I am increasingly convinced that the delusion was real. However, by degree, I think mainstream media has increased its tendency toward entertainment for the sake of ratings rather than reporting events. Ratings generate advertising and that's where the big bucks take over.

As I try to limit my skepticism short of being cynical, every time I read something gun related, I ask myself about the motivation of the writer. To be sure there are many fine writers out there who are able to take factual information and report it in an interesting way without exaggeration, falsehoods or catering to some benefactor advertiser. Unfortunately, there are some who lean the opposite way. So, why do I keep reading all this stuff?

Separating facts from bull@#\$\$% is my responsibility as a reader. The same way as radar is used to detect incoming aircraft, over the years I've learned when to raise my bull-dar antenna and use the same criteria that the Supreme Court once used in identifying porn: I'll know it when I see it. While there are innumerable situations when the reading doesn't strike true, there are several common scenarios that regularly have me grimacing.

Conclusions and recommendations that don't follow the findings within an article just do not make sense. How can an accursed trigger pull and failure of one third of the ammo tested ever result in a positive recommendation for a defensive firearm? I recall an even more egregious recommendation for a firearm some years ago that had many more defects but was recommended since it was inexpensive. I'll repeat what I've said many times, namely that I am not an expert in self defense. Nevertheless, I do have my opinions. While I don't think you need to mortgage the ranch for a defensive piece, one on which your life depends is never cheap enough to warrant its recommendation on that basis alone if it isn't 100% reliable. Now, if the author had said something like "this piece of crap is not worthy of consideration for defense but is so cheap you might have fun plinking with it" it would have been a more credible article.

Reporting of group sizes are another source of constant irritation. Previously, I expressed my opinion on always throwing out the fifth flyer that would make the group look bad. It makes no sense that one out of every five shots contains an anomaly. When the flyer is due to shooter error it would be unfair to tag the ammunition with the flyer. I certainly have enough shooter error under my belt but it is not a

regular cadence one out of five. Eliminating shooter error and having one out of five rounds removed from the group is disingenuous at best. If boxes of ammo were labeled "one out of five rounds in this box will not meet the performance standards of the rest of the cartridges in the box" we would not buy it. At least I wouldn't.

Related to the incredulity of the fifth flyer are some of the groups in general. For arguments sake, I'll concede that most professional gun writers are much better marksmen than me. (I'd guess there would be a long line of shooters who would agree with that.) I'd also estimate that most of them probably test significantly more guns and ammunition in a year than I've tested over my life. With that many guns and that much ammo, they are bound to get the bad with the good. Yet, article after article, with one or two very tight groups, all the others are "respectable." How about one that says "despite trying "umpteenth" different loads I could not get this gun to shoot a decent group" or "these three loads were good, these three were okay and run to the hills to avoid these last three"?

Recommendations based on accuracy of very pricy guns gets a bit dicey. As far as price, I believe that if you can afford it and you like it, for any reason or no reason, that's just fine. It's analogous to cars. If there is something on wheels that tickles your fancy and you don't mind the price tag, no one should have any opinion on what you do with your money. However, if the justification for the car is performance only, buying a more expensive car that doesn't perform as well as a lesser ticketed one does not make sense. So too with guns.

I have a handful of rifles that are sub-MOA. None of them cost me over \$865; the least expensive one was \$200 at the time of purchase. For comparable new models, I would estimate today's prices for the same battery would range from several hundred dollars to maybe \$1,500 or so. Therefore, I shake my heads when I see comparable performance touted at price tags of \$3,000, \$4,000, \$5,000 or more. Again, if you like, buy it, but just for accuracy that can be had at a much more reasonable price? I don't get it.

In the end, use your own judgment on what makes sense and what doesn't. While I wish the world were different, gun rags frequently perform no better (or worse) than mainstream media does when it reports news. Some reporting rings true and other reporting leads to dismissal or reprimand when someone is caught in the act of "making the news."

On a side note, the vast wasteland of the boob tube broadcasts lots of other entertainment as we all know. During a recent lull in new shows, my DVR was scheduled to record some older Law and Order episodes. This is the original series, before all the spin-offs. Season 5, episode 22 first aired on May 17, 1995 during the era of detectives Lennie Briscoe and Mike Logan, played by Jerry Orbach and Chris Noth. The story is about a murdered psychiatrist and a multiple personality suspect. (Hey, there's nothing wrong with mindless entertainment.) Anyway, the reason I mention it is because about 22 minutes into the show (including of course, a ridiculous number of commercial messages) the detectives are in the suspect's apartment and there on the wall is a silhouette poster complete with chicken, pig, turkey and ram. Who knew we were so important back then to be displayed in a then prime time show? It made me smile so I thought I'd share it with you.

AIR production guns with iron/open sights. Your best 5-shot group at 18 Yards. Groups must be fired from an IHMSA legal position. No benchrest or artificial support allowed.

### General Rules:

All entries must be shot with IHMSA legal guns. Production, Revolver, and Unlimited guns are allowed in the Burris, Weaver and Merit classes.

### Witness:

Winning groups must be witnessed by an IHMSA or NRA member. Eligible winning targets must be signed and dated by the shooter and witness. Also, please include the shooters IHMSA number and the witness's IHMSA or NRA number by their name. A witness is not required to enter but is required to win.

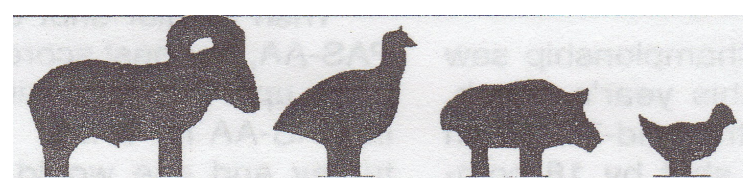

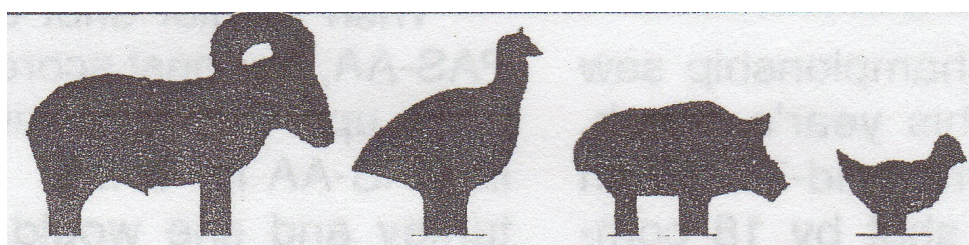

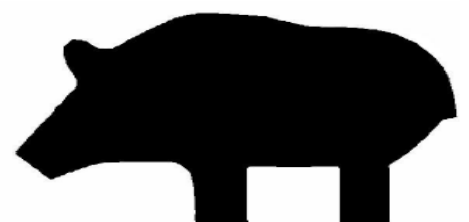

## Match Publication Policy

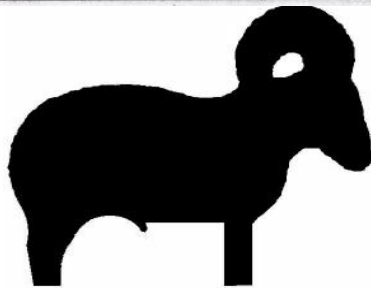
As we continually have new match directors, following is the IHMSA News' policy on publication of state, regional, and "specialty" match notices and match results.

Any IHMSA sanctioned club in good standing may publish a notice of their club's state or regional championship match at no charge for three months. State match notices are limited to 2 1/4 "x5". Regional match notices are limited to 4 3/4"x5". If a club is holding a "specialty" match and that match does not replace one of these championships, the *IHMSA News* will publish a 2 1/4"x5" notice at no charge one time. These notices will run in Section B only. The club may publish additional notices of the same size for \$45 per issue. Ads must be prepaid before printing. All payments are to be sent to IHMSA HQ, P.O. Box 22356, Cheyenne, WY 82003. The club may specify whether the paid notice is published in Section A or B.

State match results can list both first and second place finishes. Regional match results can list first, second, and third place finishes. "Specialty" matches replacing a state championship may publish first and second place finishes. "Specialty" matches replacing a regional championship may publish first, second, and third place finishes. All other match results wherein the total number of handgun silhouette entries exceeds 11 (including all IHMSA, NRA & non-member guests) can list only the first place finish. Matches with less than 11 total handgun entries as defined above can list all IHMSA handgun entrants and their place. Regardless of the above, all 40's, 60's, and 80's (depending on the number of rounds fired at the match) can be published from ANY IHMSA match.

An IHMSA club holding a dual sanctioned (IHMSA/NRA) match may submit a match report for publication in the *IHMSA News* containing both IHMSA and NRA results. The number of published NRA results may not exceed the number of published IHMSA results. Publication is limited to IHMSA sanctioned handgun disciplines only.
