REQUEST FOR NOMINATION CALIFORNIA STATE DIRECTOR



EDITORIAL IHMSA AND NRA

IHMSA was founded just over one year ago in response to the need and desire of big bore handgunners to have a standard stef of rules for metallic islinouette shooting and an association to administer short an organization of nearly 1300 members in every state in the union and a few foreign countries. Virtually all of them are active handgunners. We have sand titlored just under 100 handgun slihouette matches including state, regional and International championships during 1977.

It is an accomplishment of which we are justly proud.

Justly proud.

In 1973, NRA recognized metallic silhouette shooting for High power rifle competition and by 1976 had 1400 classified shooters with 74 sanctioned tournaments being held during that year. Interest and competition has increased to the point where the range capacity of 288 shooters was filled for the 1977 NRA National Championships held at Black Carmon range in Phoepix core the Jabor core the 1975 of the 1975 o

National Championships held at Black Caryon range in Phoenix over the Labor Day weekend.

After the Cincinatti meetings, NRA President Mustin appointed more members to the NRA silhouette committee and issued instructions to explore and develop other forms of metallic silhouette shooting in addition to high power rifle. Foremost were smallbore rifle and nistol.

RULE CHANGES

NOTE: All new rules will go into effect as of January 1, 1978. For the balance of the ear, the 1977 rules will apply although match sponsors, at their option, may include ompetition for any of the new classes.

At the IHMSA Executive meetings of October 22-23, the following proposals and rule changes were voted in for 1978:

1. In addition to our present categories of Production and Unlimited, IHMSA has added a third category to be called MODIFIED PRODUCTION as follows:

MODIFIED PRODUCTION being a gun with the original barrel, caliber, frame and sight radius as manufactured. Allowable modifications to include any metallic sight combination, target triggers and trigger shoes, recoil reducing modifications such as Maq-ma-porting or other gas venting, accessory ribs and any internal modifications. Custom grips will be allowed so long as they do not support the wrist or arm. OVERALL WEIGHT not to exceed 3% pounds, unloaded, barrel length not to exceed 15-inches.

The Modified Production category will be shot OPEN CLASS, FREESTYLE

During 1978, should enough competition develop in this category to so warrant, then IHMSA, upon approval of the Directors, will recognize modified production classes

2. An OPEN STANDING class has officially been added to the production category. Any standing position will be allowed with the gun being supported only by one or both hands. During 1978, should enough competition develop in this class to so warrant, then IHMSA, upon approval of the Directors, will add additional Standing classes by

averages.

3. HiMSA HAS adopted a weight limit of 3% pounds, unloaded, for the Modified production category, and a weight of 4% pounds for the Production and Unlimited extenders, and a harvel length of 15-inches for all categories and classes, Production, Modified production and Unlimited.

Note: No proposals or motions for any type of scoped handgun competition were passed due to the lack of interest throughout HiMSA's membership.

6. The Unlimited category has been divided into two classes as follows:

7. A motion was passed that any match sponsor could schedule any or all categories and classes at his option to meet whatever competition is available in his area.
8. Classification cards will be developed, probably on the back of the membership card, and must be presented at any match, properly filled in with the shooter's maximus according.

previous scores.

9. A mandatory rule was passed providing for the placement of the rams on their stands. "The rams shall be placed so that the center of gravity is no more than one

stands. "The rams shall be placed so that the center of gravity is no more than one inch in front of the topple point."

As a simple explanation, the official width of the ram's feet is 4-inches. The rams should be moved carefully backward on their stands with the feet overhanging to the backside until the topple point is achieved. From that point they may be moved forward to achieve stability but, as the rule calls for, not more than one inch forward of this topple point. It is suggested that this final resting place be marked by spraying around the feet with black target paint or otherwise so that the rams may be replaced in the same place each time they are reset.

Special Note: The Stillwater Firearms Association of Fallon, Nevada has designed what we consider to be the best stand possible for the rams. A self-addressed envelope will bring a copy of the diagram from Tom Lammel, 1225 Gummow Dr., Fallon, Nevada 88406.

10. Trigger pull. A motion carried that any safe trigger not subject to accidental discharge would be allowed.

Stould any round be discharged before the command to load, the shooter would be disqualified for that day. Should any round be fired after the command to load, but before the command to fire it will be judged a lost shot.

11. A unanimous vote that no alcohol or drugs be on or near the firing line of any range hosting an IHMSA match.

12. Motion passed that when a shooter fires his last unclassified score and becomes classified, he may refire in his class for record only on that day, not for trophy.

13. Step-ups: A step-up rule was passed that if a competitor wishes to shoot his production gun in the modified class and-or the Unlimited class, he must first shoot his production gun in his production gun in his production gun in his production gun in his production sup in his production supplied to the supplied of the su

unsportsmanlike conduct and behavior with authority for disciplinary actions to be taken by the board of Directors.

15. International Championships: Motion passed that any club, group or organization desiring to bid for the Internationals should submit a bid by April 1, 1978, at which time the Championships committee would consider all bids with the primary consideration being the best interests of the shooters and IHMSA, and then submit said bids to the full Board of Directors for final decision.

16. Several items, while not made part of the official rules, were suggested as recommendations to sponsoring clubs or were left to the option of said clubs.

EXECUTIVE MEETING

The first main order of business at the xecutive meeting on the evening of The first main order of business at the Executive meeting on the evening of October 22 was the election of the International Executive Director. John Adams and Elgin Gates were nominated. Adams declined on the basis of family and business obligations and Gates was then elected by unanimous vote to a term of two years.

nition of Adams' long dedicated Recognition of Adams' long dedicated service and personal sacrifices for IHMSA were discussed and properly acknowledged by all present. Elgin Gates asked for a show of hands to appoint Adams as the first Life Member of IHMSA and Director Emeritus. The response was unanimous.

At Gates request, Bob Zwirz will
continue as the Eastern Executive
Director and Coordinator of the Advisory
Committee. Gates then appointed Bert
Stringfellow as the Western Executive
Director and asked all State directors
present to continue in their capacity. He
then announced that other State Directors would be appointed as needed and committee assignments made. The regu-lar order of business continued and carried over to the evening of October 23.

In this area we are very pleased to publish a column by Bert in THE SILHOUETTE. In the still young sport of handgun metallie silhouette shooting there is a great shortage of solid ballistic information.

RULE CHANGE PROPOSALS

May 11, 2020

I am submitting this proposed rule change per Section 1-G, paragraph 2-A, reading "...the board may act on rule change proposals at any time during the year."

Current wording would be replaced with proposed wording.

Current wording, from Section IV: Competitor Classification, Section A, Paragraph 7-B, regarding conversion of 60 & 80 round scores to 40 rounds:

"For the purpose of converting 60 and 80 round aggregate scores, each category score shall be converted to the 40 round equivalent and then added together."

Proposed wording:

"For the purpose of converting 60 and 80 round aggregate scores, each category will be added together and then calculated by multiplying a 60 round aggregate score by 2/3 and an 80 round aggregate score by ½. Any remaining fraction will then be dropped."

Supporting argument:

This rule applies to making consistent the scores submitted to the various Presidents Club aggregate scores, and entry into those categories. The example below should make it obvious as to why this rule should be changed.

Example: Shooter "A" fires 80 round scores of P-78, R-78, U-78, S-46, totaling 280x320. Under current rule, his score converts to 39, 39, 39, 23, and totals 140 for 4-gun agg. Shooter "B" fires scores of P-79, R-79, U-79, S-45, totaling 282x320. But when converted, his scores become 39, 39, 39, 22, and only totals 139 and is denied entry to the Presidents Club.

It is irrational that a shooter with a 280 to be credited with shooting a 140 agg but a score of 282 can be reduced to 139. Shooter A should be credited with a 140, Shooter B should be credited with 141.

The proposed rule change addresses and corrects this anomaly. I thought we corrected this several years ago, but the problematic wording is still in the 2016 Rules Book.

As most board members know my proposal for red dot sights, which I submitted in 2017, was allowed to expire w/o being voted on allowing red dot sights on revolvers & production guns.

Reason for this proposal was to level the playing field for older shooters, who can no longer compete against much younger shooters with an iron sight set-up & also increasing entries in both categories. Most all shooting disciplines across the world have adopted red dot sights over the past several years.

There's an old saying, "If you don't change with the times you are going to die on the vine"

My reasoning behind this again, was to bring back some older shooters who have quit our fantastic sport over the past few years, plus several of us who are now struggling with eye problems & increase the entries in both production & revolver classes, which have steadily declined over the past several years, & most all of us will agree with that.

So, here is my proposal, I know, & I'm well aware I will catch some flack about increasing a couple more classes, but here is.

Add Two Practical Hunter revolver classes - PH .22 & PH Long Range BB, allowing red dot sights in both classes. (1) Weight limits not to exceed four pounds six ounces. (2) Overall length same as production,18 inches. (3) Red dot sights, with a power limit not to exceed 1 ½ power, which is what most manufacturers use. Iron sight shooters may compete in these two new classes if they so desire.

Some of you may or may not be aware of this, but the Practical Hunter category was a direct result of a proposal I made several years ago & it is one of the main reasons that Oklahoma City Gun Club is averaging over 60 entries per monthly matches & that number will only increase at our club as well as other clubs across the country with the addition of these two new revolver classes, no doubt in my mind whatsoever. The PH category has literally exploded at OKC over the past two years.

Section I General

C. Membership

I. PRACTICAL HUNTER RULES

1. Class Descriptions:

The purpose of the class is to provide a course of fire that simulates the conditions and distances a handgun hunter would encounter in the field. The intent of the class is to have handguns on the firing line that are representative of what would be commonly used for hunting. All three classes will be shot from any SAFE freestyle shooting position including prone, kneeling, sitting, or standing.

- A). Practical Hunter Long Course will be shot on the 200 Big Bore range with the standard full size targets at their normal ranges.
- B). Practical Hunter Short Course will be shot on the 100 meter Field Pistol range with the standard targets at their normal ranges, using standard field pistol cartridges only.
- C). Practical Hunter . 22LR Course will be shot on the 100 yard Small Bore targets at their normal ranges.

2.Class Rules:

- 1. Any hunting style handgun with a maximum length of 21 inches.
- 2 Optics are allowed up to a maximum of 6X power. The use of higher variable power scopes will be allowed, But they must not be used over 6x during the course of fire. The use of fixed power scopes over 6x is not allowed.
- 3 Guns must be as manufactured with only cosmetic modifications.
- 4 Ported barrels are allowed as long as they are shot from a SAFE position.
- ⁵ A rest such as a bipod or a sandbag supporting the barrel in the prone position may be used by an unclassified shooter and by shooters in classes A and AA. Allow Artificial support in practical hunter for shooters up to 12th birthday at non-championship matches.

J. ULTRA 500 RULES

- 1.IHMSA rules for Ultra 500 meter shooting shall be identical to those for Big Bore 200 meter shooting except as follows.
- 2.Two categories will be added: Ultra 500 Unlimited and Ultra 500

RULE CHANGE PROPOSAL

Current Rule SECTION IX Match Procedures

- J. Protests
- 2. All official protests must be submitted to the Match Director in writing, accompanied by a fee of US \$10.00, within one hour of any alleged violation. The \$10.00 fee shall be awarded to the party found in favor of by the jury.

Proposed rule change to read:

2. All official protests must be submitted to the Match Director in writing, accompanied by a fee of \$10.00 local currency, within **24 hours** of any alleged violation **and/or one hour** after the completion of the competition including shoot off,s whichever occurs first.

The \$10.00 fee shall be awarded to the party found in favor of by the jury.

The request for the rule change comes from incidents at the 2019 SSAA IHMSA Australian National Championship, Little River, Victoria. Allegations of incorrect scoring were made to the same competitor following 2 incidents; however, this did not become apparent until the following day when the scores were posted, hence later than the 1 hour of opportunity to submit the complaint.

Current rule SECTION IX Match Procedures

- E. Scoring
- 5. When wind conditions prevent one or more targets in a bank from being set and remaining in position without artificial support in accordance with section VIII-H, the target(s) shall be fastened clamped/fixed to the stand(s), all shots striking such target(s) anywhere shall be scored as hits provided the shot was from the competitors firearm in the correct sequence of fire, was not dirt spray from a missed shot causing paint to be removed from the target. During Championship matches when targets are clamped during such wind conditions ALL hits must be verified by a suitably experienced range officer or match director.
